Institutional Authorization

Licensure Pathway

Candidates applying for a teaching license in Delaware do so through the direct licensure pathway. Direct licensure is available when a state allows candidates to be licensed upon completion of a program that is approved in the state of Utah. Candidates apply for licensure upon WGU confirming completion of an out-of-state program. They are not required to obtain a Utah license. *Advanced programs are for already licensed teachers who want to add an additional teaching area or field to their licenses (or a separate license for Educational Leadership). These programs are not intended for aspiring teachers seeking initial licensure.

Prior to enrollment, students interested in the MA Mathematics Education program or MA Science Education program should request an evaluation through the Delaware Educator Data System (DEEDS) of coursework and/or testing needed to be eligible for certification in an additional area.

Candidates seeking to add an endorsement in mathematics, science, and special education should contact licensure@wgu.edu prior to enrollment.

The following program is not available in Delaware:

- *BA Special Education (Mild to Moderate)* – Delaware requires dual endorsement for Special Education certification. Therefore, students in Delaware may not enroll in this program, as they will not receive a teaching certificate.
