Institutional Authorization

Western Governors University is authorized to provide its educational programs in Hawaii through a state authorization reciprocity agreement (NC-SARA). More information about NC-SARA is available on their <u>website</u>.

Licensure Pathway

Candidates applying for a teaching license in Hawaii do so through the direct licensure pathway. Direct licensure is available when a state allows candidates to be licensed upon completion of a program that is approved in the state of Utah. Candidates apply for licensure upon WGU confirming completion of an out-of-state program. They are not required to obtain a Utah license. Complete details on licensure requirements in the state of Hawaii as well as information on applying using the direct licensure pathway can be found in the licensure handbook.

^{*}Advanced programs are for already licensed teachers who want to add an additional teaching area or field to their licenses. These programs are not intended for aspiring teachers seeking initial licensure.

Educators holding a current Hawaii teaching license can apply to add a teaching field to that license by completing a state-approved teacher preparation program in that field, by completing coursework, or by passing the appropriate content exam. Educators looking to add a new teaching field at a new grade level will need to take the corresponding PLT exam. For further information on these options and on which endorsements are available, please see the <u>instructions</u> for adding a field to a Hawaii license.

The following program is not available in Hawaii:

• MS Educational Leadership – Hawaii requires that educational leadership candidates complete in-state training through the Hawaii Certification Institute for School Leaders (HICISL) program, coordinated by the Hawaii Department of Education. Thus, Hawaii educators cannot earn educational leadership certification through completion of a WGU program.
