Institutional Authorization

WGU is known in Indiana as "Western Governors University Indiana" or "WGU Indiana." WGU Indiana was chartered by <u>Executive</u> Order 10-04 under Governor Mitchell E. Daniels, Jr. on June 11, 2010.

Licensure Pathway

Candidates applying for a teaching license in Indiana do so primarily through the direct licensure pathway. Direct licensure is available when a state allows candidates to be licensed upon completion of a program that is approved in the state of Utah. Candidates apply for licensure upon WGU confirming completion of an out-of-state program. They are not required to obtain a Utah license. Those enrolled in the BA Elementary Education program will use the approved licensure pathway. An approved licensure pathway is available when a WGU education program is approved in a state. A candidate may apply for a license in that state based on state program approval. Not all programs are approved in all states. Complete details on licensure requirements in the state of Indiana can be found in the licensure handbook.

The following programs are not available in Indiana:

- BS Science Education (Middle Grades) Indiana only offers subject-specific middle school science licenses. Therefore, this program will not meet Indiana requirements.
- MA Science Education (Middle Grades) Indiana only offers subject-specific middle school science licenses. Therefore, this program will not meet Indiana requirements.
