## Institutional Authorization

Western Governors University is authorized to provide its educational programs in Massachusetts through a state authorization reciprocity agreement (NC-SARA). More information about NC-SARA is available on their [website](#).

## Licensure Pathway

Candidates applying for a teaching license in Massachusetts do so through the direct licensure pathway. Direct licensure is available when a state allows candidates to be licensed upon completion of a program that is approved in the state of Utah. Candidates apply for licensure upon WGU confirming completion of an out-of-state program. They are not required to obtain a Utah license. \*Advanced programs are for already licensed teachers who want to add an additional teaching area or field to their licenses (or a separate license for Educational Leadership). These programs are not intended for aspiring teachers seeking initial licensure.

Sheltered English Immersion Teacher Endorsement for initial licensure programs: Graduates of WGU teacher preparation programs will be eligible for 5-year Preliminary certification in Massachusetts. Educators must obtain the Sheltered English Immersion (SEI) endorsement in order to be eligible for an Initial teaching certification. To be eligible for the Sheltered English Immersion endorsement, they must pass the [MTEL Sheltered English Immersion \(56\)](#) exam.
