Institutional Authorization

WGU is known in Nevada as "Western Governors University Nevada" or "WGU Nevada." WGU Nevada was established by an <u>Executive Proclamation</u> of Brian Sandoval, Governor of the State of Nevada, on June 16, 2015.

Licensure Pathway

Candidates applying for a teaching license in Nevada will use one of three licensure pathways (reciprocity, approved, or direct) depending on their program. Licensing through reciprocity means that candidates must first acquire a Utah teaching license before applying for licensure in their state. Not all states require reciprocity for all programs. An approved licensure pathway is available when a WGU education program is approved in a state. A candidate may apply for a license in that state based on state program approval. Not all programs are approved in all states. Direct licensure is available when a state allows candidates to be licensed upon completion of a program that is approved in the state of Utah. Candidates apply for licensure upon WGU confirming completion of an out-of-state program. They are not required to obtain a Utah license. Information on which pathway a certain program utilizes and complete details on licensure requirements in the state of Nevada can be found in the licensure handbook.

^{*}Advanced programs are for already licensed teachers who want to add an additional teaching area or field to their licenses (or a separate license for Educational Leadership). These programs are not intended for aspiring teachers seeking initial licensure.

The following WGU programs also meet the educational prerequisites for a **conditional** teaching license using the <u>Alternative Route</u> to <u>Licensure</u> (ARL) in Nevada:

- MAT Elementary Education
- MAT English Education (Secondary)
- MAT Mathematics Education (Secondary)
- MAT Science Education (Secondary) Biological Science Content Area Only



Upon meeting eligibility requirements, teacher candidates enrolled in these programs may apply to the Nevada Department of Education for a three-year <u>conditional</u> ARL teaching license. During that time, candidates may accept an offer of employment from a P-12 school district as a teacher and work while completing their program requirements, including demonstration teaching.

The following program is not available in Nevada:

• BS Science Education (Middle Grades) – Since Utah does not issue a middle grades science license, students should not enroll in this program.
