Institutional Authorization

Western Governors University is authorized to provide its educational programs in South Dakota through a state authorization reciprocity agreement (NC-SARA). More information about NC-SARA is available on their [website](#).

Licensure Pathway

Candidates applying for a teaching license in South Dakota do so through the direct licensure pathway. Direct licensure is available when a state allows candidates to be licensed upon completion of a program that is approved in the state of Utah. Candidates apply for licensure upon WGU confirming completion of an out-of-state program. They are not required to obtain a Utah license. Educational Prerequisites

WGU's education preparation programs (initial licensure programs and MS Educational Leadership[^]) do not meet all of the educational prerequisites for professional licensure in South Dakota. To obtain a South Dakota license, applicants must complete an approved [South Dakota Indian Studies course](#). Applicants are also required to complete at least one clock hour of [suicide awareness and prevention training](#) from an approved provider. WGU programs do not satisfy the South Dakota Indian Studies course requirement or the suicide awareness and prevention training requirement. Applicants will not be issued a certificate until these requirements have been completed.

[^]Most individuals holding an initial South Dakota teaching certificate have already satisfied this requirement.

*Advanced programs are for already licensed teachers who want to add an additional teaching area or field to their licenses (or a separate license for Educational Leadership). These programs are not intended for aspiring teachers seeking initial licensure.

WGU advanced programs (except MS Educational Leadership) meet the educational prerequisites for endorsement of an existing South Dakota teacher license (note that the requirement for South Dakota Indian Studies and suicide awareness and prevention

training are required for the initial South Dakota license to which the endorsement is added). Details on adding an endorsement to a South Dakota teaching license are available in the [licensure handbook](#).

To obtain a license in South Dakota, an applicant must have completed the teacher education program within five years of the date of the application. If more than five years have elapsed since the completion of the teacher education program, then the applicant must provide documentation of six semester hours in the applicant's field of study from an accredited four-year institution in the five years immediately preceding the date of the application for a license.
