Institutional Authorization

WGU is known in Tennessee as "Western Governors University Tennessee" or "WGU Tennessee." WGU Tennessee was established through a <u>Memorandum of Understanding</u> between Bill Haslam, Governor of the State of Tennessee, and Robert W. Mendenhall, President of Western Governors University, on July 9, 2013. WGU is eligible to offer its programs in Tennessee based upon this Memorandum of Understanding.

Licensure Pathway

Candidates applying for a teaching license in Tennessee do so through the direct licensure pathway. Direct licensure is available when a state allows candidates to be licensed upon completion of a program that is approved in the state of Utah. Candidates apply for licensure upon WGU confirming completion of an out-of-state program. They are not required to obtain a Utah license. Complete details on licensure requirements in the state of Tennessee as well as information on applying using the direct licensure pathway can be found in the licensure handbook.

Per the <u>Tennessee State Board of Education Policy 5.502(1)(g)</u> - Licensure Requirements for Military Spouses: Educators who hold an active license (initial or professional) from a state other than Tennessee may be issued a Tennessee Practitioner License upon providing documentation of active military dependent status. Licensure applications for military spouses will be expedited. Prior to renewing or advancing the license, educators must submit passing scores on required content assessments.
