Institutional Authorization

WGU is known in Washington as "Western Governors University Washington" or "WGU Washington." WGU Washington was established by the passing of Substitute House Bill 1822, effective July 22, 2011 and was signed into law by Christine Gregoire, Governor of the State of Washington. WGU offers its programs in Washington under that <u>legal authority</u>.

Licensure Pathway

Candidates applying for a teaching license in Washington do so primarily through the approved licensure pathway. An approved licensure pathway is available when a WGU education program is approved in a state. A candidate may apply for a license in that state based on state program approval. Not all programs are approved in all states. Those enrolled in the MAT English Education (Secondary) program who wish to obtain an English Language Arts certification will use the direct licensure pathway. Direct licensure is available when a state allows candidates to be licensed upon completion of a program that is approved in the state of Utah. Candidates apply for licensure upon WGU confirming completion of an out-of-state program. They are not required to obtain a Utah license. The following program is not available in Washington:

• BA Special Education (Mild to Moderate) – Washington requires dual endorsement for Special Education certification. Therefore, students in Washington may not enroll in this program, as they will not receive a teaching certificate.
