## **Institutional Authorization**

Western Governors University is authorized to provide its educational programs in Wisconsin through a state authorization reciprocity agreement (NC-SARA). More information about NC-SARA is available on their website.

## **Licensure Pathway**

Candidates applying for a teaching license in Wisconsin do so through the direct licensure pathway. Direct licensure is available when a state allows candidates to be licensed upon completion of a program that is approved in the state of Utah. Candidates apply for licensure upon WGU confirming completion of an out-of-state program. They are not required to obtain a Utah license. Complete details on licensure requirements in the state of Wisconsin as well as information on applying using the direct licensure pathway can be found in the <u>licensure handbook</u>.

#### **Educational Prerequisites**

WGU's programs meet most of the educational prerequisites for professional licensure in Wisconsin for the licenses listed below. Wisconsin requires that candidates for licensure complete 18 weeks of student teaching. The Utah program which serves as the direct licensure vehicle for certification requires only 12 weeks of student teaching for completion of the degree program. Upon review of a candidate's Wisconsin licensure application, Wisconsin DPI may issue a three-year educator license noting "Student Teaching – Not Enough Weeks" as a stipulation. This stipulation is not a deficiency and can be removed upon completion of 18 weeks of successful full-time teaching experience by having the employing school district complete the <u>verification of employment form</u>.

Wisconsin requires candidates to complete coursework in the study of Wisconsin Indian tribes and environmental education, which is not covered by WGU's programs. Candidates for licensure who have not satisfied these requirements prior to applying for teacher certification in Wisconsin may be issued a three-year educator license with stipulations, provided they have passed all Praxis exams required for Wisconsin certification. Candidates for licensure in Wisconsin are required to satisfy these requirements as part of the three-year professional development period. Educators holding current Wisconsin teaching licenses can apply for additional licensure areas after completing a state-approved, regionally accredited teacher preparation program in the new teaching area. Educators currently licensed in math, science, social science, or English language arts have the option of adding math, science, or social science to their license by passing the Praxis content exam.
